PARENTAL CONSENT AND CONFIDENTIALITY UNDERTAKING ("UNDERTAKING")

1- Parental Consent. I am the parent or legal guardian of the Child(ren) named below who may be participating in the Budge beta playtesting program ("Budge Playgroup") organized by Budge Studios Inc. ("Budge"). I have read Budge's Privacy Policy and agree, in my name and in my (each of my) Child(ren)'s name, to Budge's collection of personal information regarding our use of any and all Budge Studios Inc. ("Budge") applications I playtest ("App" or "Apps"). 4- Intellectual Property. I agree to participate in this voluntary program and understand that I will receive no compensation whatsoever. Furthermore, I confirm that any rights in and to any ideas and/or feedback I submit to Budge shall be automatically assigned in full and without any compensation from Budge. I understand that Budge is not obligated to release the App, use my feedback or (if I have consented to it below) include the name of the Child(ren) in the credits.

5- General. I understand that Budge may, without notice, discontinue the Budge Playgroup and/or a specific playtest at any time for any reason. At any time, to terminate your participation in the Budge Playgroup, please email playgroup@budgestudios.ca. This Undertaking will be governed by the laws of the province of Quebec (Canada) and the courts located Montreal (Quebec, Canada) shall have exclusive jurisdiction. Sections 1, 3 and 4 herein shall survive any termination of this Undertaking.
